#### NEW FEATURES

##### April 2024

- Table Form Element - users can now add tables inside of forms where users can dictate the number and types of rows and columns.
- Enhanced Weather Table - added optional additional weather information that can be viewed during the inspection and placed on inspection reports. Additional information includes current conditions, the next few days of forecast, as well as information about the last storm, current storm, and any upcoming storms.
- Delete Inspections - added an optional feature to allow Org Editors to delete signed inspection reports.

##### March 2024

- Custom Data Report Builder. We have added a new reporting feature that allows you to build your own custom reports with your data and choose the parameters of that report.

#### ENHANCEMENTS

##### April 2024

- Added steps for site people & roles, site notification recipients, and site inspection assignments into the site wizard. These can be skipped by clicking "Finish" without interfering with the creation of the site.
- Added the capability for Viewers to affix 2nd and 3rd signatures.
- Made improvements to the password strength requirements.
- Changed the icon for required questions to be larger and to turn gray when the question is answered.
- Added a dynamic required question icon to control type dropdowns and controls to indicate a question inside the control type / control that will disappear once the requirement is satisfied.
- Restricted the state field during site creation to two character abbreviations.
- Added "Cancel" buttons to more steps in the site creation wizard.
- Added a requirement for both 2nd and 3rd signature statements to have a label.
- Added a "Save and Add Another" button to the action item page.
- Changed attachments to display the file name of the attachment instead of attachment #.

##### March 2024

- Change inspection due dates to display the entire due window on the inspection cards rather than just the final due date.
- Removed the + Site button from the Director management page to properly direct people to add sites under companies and divisions instead.
- Added the text "Closed Date" to the action item page date picker to better illustrate its purpose.
- Added additional source popups to pages where weather information is displayed on the site activity report, site page, and daily precipitation totals report.

# BUG FIXES

## April 2024

- Fixed an issue that could cause a white screen when deleting photos from controls.
- Fixed an issue that could cause a site's latitude and longitude to not display properly when switching quickly from site to site.
- Resolved an issue that could cause Control type child forms to be unavailable to child organizations.
- Removed the text "Estimated Date of First Inspection" from the site wizard that was showing up when not needed.
- Corrected a formatting issue that could cause long site names to overlap in the site creation wizard.
- Fixed an issue that could cause the zoom in and out buttons on the site creation wizard to be covered by the chat icon.
- Corrected an issue that could sometimes push the effective/expiration dates forward by one day when adding a permit.
- Corrected an issue that could cause the dropdown text placeholder text to disappear if it was deleted.
- Corrected an issue that could cause the "Closer" column in the action log report to not fill in properly if the user was not logged in when closing the action item.
- Corrected an issue that could cause an error when adding people to an organization's people & roles.
- Fixed an issue that could cause a white screen when searching for users who were still pending.

## March 2024

- Fixed an issue that could cause photos to continue display as uploading after they successfully uploaded.
- Fixed an issue with the save button when editing photos.
- Fixed an issue causing some holidays to not appear on the inspections calendar.
- Fixed a formatting issue that could cause the bulk action item closing information to appear when closing a single action item.
- Corrected a dashboard display issue that could cause inactive company/division index letters to appear in the organization list.
- Fixed an issue with the Microsoft SSO option that could cause people to not connect to their Microsoft logins correctly.
- Removed times showing next to the closed date for action items.
- Fixed an issue that could cause a non-functioning save title button to appear when viewing an inspection.
- Corrected an issue that could hide the close page button when a user is editing their profile.
- Fixed an issue that could prevent 7-day forecasts from being automatically attached to weather inspection reports.
